This is what we have. Not too much recent and the USGS and Carlson were looking for rare fish and not trout. Hopkinton below ozonia road to its mouth and trout brook below 11B are stocked trout streams. The EB St Regis is also stocked from Ft. Jackson to the county line and by R5 up to the Falls. The Saint Regis Mohawk Tribe in conjunction with USGS also stock this area with Atlantic Salmon. All in all they are pretty nice trout streams with mostly wild fish.
