Thank you for the recent call regarding the updated evaluation of potential visual effects on the historic-architectural resources caused by the revised layout of the turbine field.

The information reviewed was contained in section 4.2 of the report titled: Roaring Brook Wind Farm: Phase 1B Archaeological Survey Interim Report-Summary of Results (JMA, October 2008).

After reviewing this information it is the opinion of this office that the revised layout of the turbine field will require no additional visual analysis for historic/cultural resources. Thank you for requesting the comments of the Office of Parks, Recreation and Historic Preservation (OPRHP). We have reviewed the project in accordance with the New York State Parks, Recreation and Historic Preservation Law, Section 14.09.

The OPRHP has reviewed the Phase IB report submitted for this project. Fifteen (15) archeological sites were identified during the field work. Eleven (11) sites were far enough away from the Area-of-Potential Effect (APE) that no further consideration was warranted. The overhead electrical line near the Orchard Historic Site (A04911.000116) was re-routed by 50 meters/165 feet from the site so no further avoidance measures are needed.

The three (3) remaining sites, Flat Rock MDS 7 (A04911.000110), Flat Rock MDS 9 (A04911.000112) and French Road MDS 4 (A04911.000114) will need to be avoided throughout construction. Therefore the OPRHP recommends individual Avoidance Plans be developed for each of the three sites noted.

It is the opinion of the OPRHP that no further archeological testing is warranted for this project with the condition that the three sites noted above are avoided as recommended.

Project Description:

Construction of a wind-powered electrical generation facility consisting of 39 wind turbines and supporting infrastructure within an approximate 7,600-acre area in the Town of Martinsburg, Lewis County. Construction of turbine access roads and placement of poles for the overhead collection (OHC) line will result in a total of approximately 0.42 acres of permanent fill impacts to wetlands, approximately 0.26 acres of which are impacts to state-jurisdictional wetlands. These activities will result in 237 linear feet of permanent impacts to statejurisdictional streams. Up to 0.38 acres of permanent forest conversion will result from clearing associated with the installation of underground (UGC) collection lines. Of this amount, approximately 0.003 acre will occur in state-jurisdictional wetlands. Construction of access roads and temporary ground disturbance and clearing (no grubbing) associated with installation of UGC lines will result in a total of 2.81 acres of temporary fill wetland impacts, with approximately 1.33 acres under state jurisdiction. 333 linear feet of temporary stream impacts will result from these activities. Clearing and construction of access roads will result in disturbance of approximately 12.09 acres of state-regulated wetland adjacent areas. To mitigate permanent impacts to wetlands and streams that result from project construction, four mitigation measures will be implemented: 1) re-construction of three existing substandard culverts to improve fisheries function; 2) improvements to existing unpaved forest roads to improve drainage and reduce erosion; 3) use of Best Management Practices during construction including an erosion and sediment control program and an invasive species control plan; and 4) implementation of a trout habitat restoration and enhancement program at Sears Pond in partnership with the Lewis County Soil and Water Conservation District.
