# 1. Introduction

## INTRODUCTION

This manual is designed to guide you through the process of registering and connecting with the Iberdrola Group through SAP Business Network. Here you will find the necessary instructions to ensure a smooth and seamless integration, whether you already have an account on SAP Business Network or are starting from scratch.

If you are already a supplier of the Iberdrola Group in SAP Business Network (having participated in bidding processes through what we at the Iberdrola Group called IBuy), you will need to update your information and/or fill out new forms.

This is because, as part of the transition process to the new Supplier portal, the Iberdrola Group has centralised the required information in updated forms. You will receive an email with instructions on how to make this update.

# 2. Glossary

## GLOSSARY

- SAP Business Network (BN): This is the SAP Ariba platform that allows us to establish business relationships with the Iberdrola Group.
- ANID (Ariba Network ID): This is the unique identification code that represents your company in the global SAP Business Network.
- IBuy: Former name by which the section “Ariba Proposals and Questionnaires” was known. From here, the requests for proposals received from the Iberdrola Group will continue to be managed in "Events", additionally, it is where the questionnaires will be to keep the organization's information up to date.
- Administrator: The person responsible for managing the supplier's account on the Ariba Network.
- Shipping location: Countries within the scope of operation.
- Organization: Company.

## GLOSSARY (cont.)

- Registered supplier: Company that already has an active business relationship with the Iberdrola Group through SAP Business Network.
- Link account: Process by which a company with an account on SAP Business Network applies to become an Iberdrola Group supplier.
- Registration questionnaire: Digital document that must be completed to start the supplier registration process.
- Registration status: Status of the registration process (pending, approved, rejected).
- SAP support: SAP Business Network support team for technical issues or questions about the platform.
